**THE TOURIST OCCUPATIONS AND ASSOCIATIONS REGULATIONS,  
1980 AND 1992****Decision made by virtue of Regulation 13(1)**

The Board of Directors of the Cyprus Tourism Organization, in exercise of the powers vested in it by Regulation 13(1) of the Tourist Occupations and Associations Regulations, 1980, has decided that the fees payable to guides for services rendered shall be as follows:

- (a) Half day sightseeing tour duration of up to 4 hours: CYP£ 8
- (b) All day sightseeing tour duration of up to 8 hours: CYP£ 13
- (c) Night sightseeing tour duration of up to 4 hours: CYP£ 8
- (d) In case of a sightseeing tour held during Christmas Day, Boxing Day, New Year's Day, Easter Day and Easter Monday, all fees mentioned above under (a), (b) and (c) shall be increased by 100%.
- (e) In case of a sightseeing tour held on Sundays and at official holidays all fees mentioned above under (a),(b) and (c) shall be increased by CYP£4.
- (f) Where a sightseeing tour is conducted in two languages at the same time an additional fee of CYP£2 shall be payable.
- (g) Overtime: CYP£2 for every hour of employment.
- (h) Where a sightseeing tour is conducted in another city other than the permanent residence of the guide, he shall be entitled to traveling expenses to the city where the sightseeing tour shall commence, not accounting his traveling time as part of his period of employment.
- (i) In case of overnight accommodation in another city other than the permanent residence of the guide, his employer shall provide him with accommodation or pay his expenses back to the city of his permanent residence:

Provided that the above fees shall apply for sightseeing tours of groups of up to 55 persons conducted by one guide.

2. The above decision was approved by the Minister of Commerce and Industry.

**THE TOURIST OCCUPATIONS AND ASSOCIATIONS REGULATIONS,  
1980 AND 1992**

**Decision made by virtue of Regulation 13(1)**

The Board of Directors of the Cyprus Tourism Organization, in exercise of the powers vested in it by Regulation 13(1) of the Tourist Occupations and Associations Regulations, 1980, has decided that the fees payable to guides for services rendered by them shall be as follows:

- (a) Half day sightseeing tour duration of up to 4 hours: CYP£ 9.50cent
- (b) All day sightseeing tour duration of up to 8 hours: CYP £15
- (c) Night sightseeing tour duration of up to 4 hours: CYP £9.50cent
- (d) In case of a sightseeing tour held during Christmas Day, Boxing Day, New Year's Day, Easter Day and Easter Monday, all fees mentioned above under (a), (b) and (c) shall be increased by 100%.
- (e) In case of a sightseeing tour held on Sundays and all other official holidays all fees mentioned above under (a), (b) and (c) shall be increased by CYP£4.
- (f) In case of a sightseeing tour held in two languages at the same time an additional fee of CYP£2 shall be payable
- (g) Overtime: CYP£ 2 for every hour of employment.
- (h) In case where a sightseeing tour of tourists is held in another city not the permanent residence of the guide, he shall be entitled to claim transportation expenses to the city where the sightseeing tour shall commence, not accounting for his traveling time as part of the period of employment.
- (i) In case of overnight accommodation in another city, not the permanent residence of the guide, his employer shall provide him with accommodation or pay his return expenses to his permanent residence:

Provided that, the above fees shall apply for sightseeing tours, for groups of up to 55 persons by one guide.

2. The above decision was approved by the Minister of Commerce and Industry.

3. The decision of the Board of Directors of the Cyprus Tourism Organization published in Supplement III (I) of the Official Gazette of the Republic under number 1613 and dated 27<sup>th</sup> of June, 1980, is hereby cancelled.

**Decision made by virtue of Regulation 13(1)**

The Board of Directors of the Cyprus Tourism Organization, in exercise of the powers vested in it by Regulation 13(1) of the Tourist Occupations and Associations Regulations 1980, has decided that the fees payable to guides for services rendered by them shall be as follows:

1. For the period commencing on 31.3.1983:
  - (a) Half day sightseeing tour duration of up to 4 hours CYP£10.45cent
  - (b) All day sightseeing tour duration of up to 8 hours CYP£16.50cent
  - (c) The remaining fees shall be those referred to under Regulatory Public Instrument No.193 under number 1711 Official Gazette of the Republic, dated 21<sup>st</sup> August 1981.
2. For the period commencing from the 1.4.1983 until 31.12.1983:
  - (a) Half day sightseeing tour duration of up to 4 hours CYP£ 11.50cent
  - (b) All day sightseeing tour duration of up to 8 hours CYP£ 18.15cent
  - (c) Night sightseeing tour duration of up to 4 hours: CYP£11.50cent
  - (d) In case of sightseeing tour held beyond the residence of the guides the fees payable for all day sightseeing tour namely CYP£18.15cent.
  - (e) In case of a sightseeing tour held at official holidays, namely Christmas Day, Boxing Day, New Year's Day, Easter Day, Easter Monday, 6<sup>th</sup> of January, the 19<sup>th</sup> of January, Green Monday, 25<sup>th</sup> of March, 1<sup>st</sup> of April, Good Friday, Good Saturday, 1<sup>st</sup> of May, 3<sup>rd</sup> of August, 15<sup>th</sup> of August, 1<sup>st</sup> of October, 28<sup>th</sup> of October, and the 24<sup>th</sup> of December, all fees mentioned above under (a) and (b) shall be increased by 100%.
  - (f) In case of a sightseeing tour on Sundays all fees mentioned above under (a) and (b) shall be increased by 50%.
  - (g) Where a sightseeing tour is held in two languages at the same time as well as a cruise an additional fee shall be payable of CYP£2.
  - (h) Overtime: CYP£2 for every hour of employment.
  - (i) In case of a sightseeing tour of tourists held in another city not the permanent residence of the guide, the guide may claim his traveling expenses to the city where the sightseeing tour shall be held, not accounting the time for his transport as part of his period of employment.

- (j) In case of an overnight accommodation in another city other than the permanent residence of the guide, his employer shall provide him with accommodation or pay his traveling expenses back to his residence:

Provided that the above fees apply for sightseeing tours of groups of up to 55 persons.

- 3. For the period from 1<sup>st</sup> of January 1984, the fees under 2(a), (b) and (c) above shall be adjusted subject to the increases in the price index afforded to Civil Servants.

**Decision made by virtue of Regulation 13(1)**

The Board of Directors of the Cyprus Tourism Organization, in exercise of the powers vested in it by Regulation 13(1) of the Tourist Occupations and Associations Regulations, 1980, has decided that the fees payable to guides for services rendered shall be as follows:

1. For the period commencing on 1.1.1989:

(a) Basic Fees as at 31.12.1983:

- (i) Half day sightseeing tour duration of up to 4 hours CYP£11.50cent
- (ii) All day sightseeing tour duration of up to 8 hours CYP£18.15cent:

Provided that, the above fees shall be adjusted from the 1<sup>st</sup> of January, 1984, subject to the increases in the price index afforded to the Civil Servants.

(b) Overtime: CYP£2 for every hour of employment:

Provided that, the above fee shall be adjusted from 1<sup>st</sup> of January 1989, subject to the increases in the price index afforded to Civil Servants.

- (c) In case of a sightseeing tour held beyond the residence of the guide the fees payable shall be those of a whole day sightseeing tour.
- (d) In case of a sightseeing tour held beyond the residence of the guide, the guide shall be entitled to payment of his traveling expenses to the city where he will conduct the sightseeing tour not accounting his traveling time as part of his period of employment.
- (e) In case of an overnight accommodation beyond the residence of the guide, his employers shall provide him with accommodation or pay his return expenses to his residence.
- (f) In case of a sightseeing tour held on Sundays the fees mentioned above under (a) shall be increased by 50%.
- (g) In case of a sightseeing tour held during official holidays, namely 1<sup>st</sup> of January, 6<sup>th</sup> of January, Green Monday, 25<sup>th</sup> of March, 1<sup>st</sup> of April, Good Friday, Good Saturday, Easter Day, Easter Monday, 1<sup>st</sup> of May, Ascension Day, 15<sup>th</sup> of August, 1<sup>st</sup> of October, 28<sup>th</sup> of October, the 25<sup>th</sup> and the 26<sup>th</sup> of December, all fees mentioned above under (a) shall be increased by 100%.
- (h) In case of conducting a cruise sightseeing tour an additional sum of CYP£2 shall be payable.

- (i) In case of a sightseeing tour held in two languages at the same time an additional fee shall be payable as follows:
- (i) the sum of CYP£3 during winter season namely from the 1<sup>st</sup> of November until 31<sup>st</sup> of March and
  - (ii) the sum of CYP£8 during summer season namely from the 1<sup>st</sup> of April until 31<sup>st</sup> of October.
2. The above fees shall be applicable in case of sightseeing tours of groups of up to 55 persons.
3. The above decisions were approved by the Minister of Commerce and Industry.

1980 AND 1992**

**Decision made by virtue of Regulation 13(1)**

The Board of Directors of the Cyprus Tourism Organization, in exercise of the powers vested in it by Regulation 13(1) of the Tourist Occupations and Associations Regulations, 1980, has decided that the fees payable to guides for services rendered shall be as follows:

1. For the period commencing from the 1<sup>st</sup> of April 1991:

(a) Basic Fees:

- (i) Half day and night sightseeing tour duration of up to 4 hours CYP£13.25cent
- (ii) All day sightseeing tour duration of up to 8 hours CYP£20.85cent

The above fees shall be adjusted, subject to the increases in the price index afforded to Civil Servants and apply from 1<sup>st</sup> of January, 1984.

(b) Overtime: CYP£ 2.30 cent for every hour of employment.

The above fee shall be adjusted, subject to the increases in the price index afforded to Civil Servants and apply from 1<sup>st</sup> of January, 1989.

(c) In case of a sightseeing tour held beyond the residence of the guide the fees which shall be collected are those of an all day sightseeing tour.

(d) In case of a sightseeing tour beyond the residence of the guide, he shall be entitled to the payment of his traveling expenses to the city where he will commence the sightseeing tour not accounting his traveling time as part of the period of his employment.

(e) In case of an overnight accommodation beyond the residence of the guide, his employer shall provide him with accommodation or pay his travel expenses back to his residence.

(f) In case of a sightseeing tour held on Sundays fees mentioned in paragraph 1(a) above shall be increased by 50%.

(g) In case of a sightseeing tour held during official holidays, namely 1<sup>st</sup> of January, 6<sup>th</sup> of January, Green Monday, 25<sup>th</sup> of March, 1<sup>st</sup> of April, Good Friday, Good Saturday, Easter Day, Easter Monday, 1<sup>st</sup> of May, 15<sup>th</sup> of August, 1<sup>st</sup> of October, 28<sup>th</sup> of October, the 24<sup>th</sup> 25<sup>th</sup> and the 26<sup>th</sup> of December, the fees mentioned in paragraph 1(a) above shall be increased by 100%.

(h) In case of a cruise sightseeing tour an additional fee of CYP£2.30cent shall be payable.



- (i) In case of a sightseeing tour conducted in two languages at the same time an additional fee shall be payable:
- (i) the sum of CYP£3.45cent during winter season namely from the 1<sup>st</sup> of November until 31<sup>st</sup> of March, and
  - (ii) the sum of CYP£9.20cent during summer season namely from the 1<sup>st</sup> of April until the 31<sup>st</sup> of October.

2. The above fees shall apply for sightseeing tours of groups of up to 55 persons.
3. The above decisions were approved by the Minister of Commerce and Industry.

1980 AND 1992**

**Decision made by virtue of Regulation 13(1)**

The Board of Directors of the Cyprus Tourism Organization, in exercise of the powers vested in it by Regulation 13(1) of the Tourist Occupations and Associations Regulations, 1980, has decided to amend its decision published in Supplement III (I), P.I. 16/91 of the Official Gazette of the Republic, under number 16 and dated 25.1.1991 by the deletion therefrom of paragraph 1(g) and the substitution therefor of the following new paragraph:

«(g) In case of a sightseeing tour held during official holidays, namely 1<sup>st</sup> of January, 6<sup>th</sup> of January, Green Monday, 25<sup>th</sup> of March, 1<sup>st</sup> of April, Good Friday, Good Saturday, Easter Day, Easter Monday, 1<sup>st</sup> of May, Ascension Day, 15<sup>th</sup> of August, 1<sup>st</sup> of October, 28<sup>th</sup> of October, the 24<sup>th</sup>, 25<sup>th</sup>, and 26<sup>th</sup> of December, the fees mentioned in paragraph 1(a) shall be increased by 100% .».

2. The above decision was approved by the Minister of Commerce, Industry and Tourism.

1980 AND 1992**

**Decision made by virtue of Regulation 13(1)**

The Board of Directors of the Cyprus Tourism Organization, in exercise of the powers vested in it by Regulation 13(1) of the Tourist Occupations and Associations Regulations, 1980, has decided to amend its decisions published in Supplement III (I), P.I. 16/91 and P.I. 199/95 of the Official Gazette of the Republic, under number 16 and 199 and dated 25th January 1991 and 14<sup>th</sup> July 1998, respectively, with the addition after paragraph (i) of the following new paragraph, numbered as paragraph (j):

- «(j) (i) An accommodation allowance of up to CYP£8 if required by the Travel Office for the guide to stay with his clients.
- (ii) An allowance of up to CYP£8 in case of sightseeing tour in nature trail for routes of more than two hours.».

The above decision was approved by the Minister of Commerce, Industry and Tourism.
